

Manager's Report

Copies of the report were provided to all AGM attendees in the meeting papers as part of the Annual Report 2022 Calendar Year.

Danny highlighted the lead role DNC played in establishing combined community efforts to help relieve homelessness in Hepburn Shire by facilitating meetings of all relevant community agencies. DNC took the lead in establishing a free shower and laundry facility which has attracted national attention and is already receiving lots of use by those in need.

Other highlights included a 62% increase in visitations to the Centre (a total of 3792), 128 graduates of our work-skills courses and the welcoming of the Daylesford U3A as a partner and tenant.

Chair's Report 2023

2023 was a year of positive outcomes.

Hepburn Shire Council (HSC) via a tender process awarded a 3-year ARC management contract to Daylesford Neighbourhood Centre (DNC). Immediately a steering committee was set up to oversee the contract, it comprises representatives from HSC, Daylesford College and DNC. A detailed operating budget, submitted to the committee by DNC, has been accepted paving the way for our ARC activation plan.

During the year a strategic plan evolved that focuses on;

- ¹ Lifelong learning.
- ² Arts, recreation, and culture.
- 3 Organisation development and support

The shower and toilet facility continues to receive widespread acknowledgement, particularly the national coverage by the ABC.

DNC, among others, is continuing to fight for a more equitable funding arrangement for The Neighbourhood House Coordination Program. For the past decade the existing indexation formula has fallen well short of real costs and this is against a background of greatly increased need in the community.

I would like to acknowledge the efforts of the Committee members who, giving freely of their time, provide a considerable depth of knowledge and expertise that ensures DNC is the best it can be.

Treasurer's Report 2023

Calendar year 2023 was a solid financial outcome for the Daylesford Neighbourhood Centre with revenue and costs in line with budget. Nett result was a loss of \$3,237. The balance sheet remains strong with a slight increase in cash over the previous year.

CY2024 will see a budget deficit as we apply some of the reserves to upgrade areas within the complex.

Manager's Report 2023

DNC continues to grow year on year with visitations up 21% on 2022. While all categories increased, the majority of growth came from the first full year of U3A making the Court room home.

Cost of living and affordable housing continue to impact the community with many requests for support and referral to relevant services and community organisations. Our own hygiene station has now been used 69 times since opening, with several people per day accessing it.

We were honored to receive the Reducing Inequalities award from Neighbourhood Houses Victoria for our hygiene station.

We have been reviewing our disability access, and with the generous support of Working Heritage (WH) we installed new automatic doors to improve access. WH have also completed a draft site plan to improve site access across the different buildings. Once the plan is complete, we will provide more detail on these major site works.

Finally, big thank you to Committee of Management, staff and volunteers who work tirelessly to support the centre. We look forward to 2024.
